## **FASB Standard 715-80 Multiemployer Pension Plan Disclosure Information As of Plan Year Ended December 31, 2021**

On September 21, 2011, the Financial Accounting Standards Board (“FASB”) issued Accounting Standards Update No. 2011-09 (Subtopic 715-80) concerning disclosures regarding employers’ participation in multiemployer plans. The purpose of the update is “to lead employers to provide more information about an employer’s financial obligations to multiemployer pension plans.” For public entities, the enhanced disclosures are required for fiscal years ending after December 15, 2011. For nonpublic entities, the enhanced disclosures are required for fiscal years ending after December 15, 2012. However, nonpublic entities may disclose such information for earlier fiscal years if they choose to do so.

To assist our participating employers in the preparation of their financial statements in light of the requirements, the Steelworkers Pension Trust (“Trust”) is providing certain information required by the disclosures that participating employers might not have readily available.
